Your feedback will help inform the development of the Community Education Strategic Plan because it will identify key themes that need to be considered by the Board of Trustees as well as proposing possible actions for the future. A draft Community Education Strategic Plan is available for you to consider. The objectives in this Plan set broad parameters to guide the consultation process.
